REGULATIONS

1. Participation

All athletes may apply to participate in the events authorized for their category based on the following guidelines:

Meeting "Valencia 2026"	 All athletes with a valid RFEA national license for 2026 season who have registered within the established period may participate (see point 3) For organisational reasons, no entries will be accepted after the entry deadline (see point 3) Only the maximum number of athletes per event indicated in the table of participation limits reflected at the end of this point will be accepted. Exceptionally, registrations of athletes may be accepted for technical criteria The organization will use the criteria it deems appropriate to designate the participants. 	
Registration of athletes without an Spanish licence	Athletes or their WA authorized AR will apply to participate through the following link: ENTRIES	
Accommodation and travel	Travel: The organisation may reimburse travel expenses only to athletes who are in the Top 25 of the European List Ranking 2025 and participate in the same event in which they have that classification. The actual cost of the ticket will be reimbursed up to a maximum of €200 for travel from outside Spain and €120 for domestic travel. To receive payment, the travel invoice must be submitted via the link to the platform that athletes or their representatives will receive. Hotel: a place in a shared room can be booked at the organisation's hotel (Hotel Beleret – Campamento street, 80 46035 Valencia) exclusively for the nights of 30 and/or 31 January, on a full-board, only for athletes accepted into the international events and always after completing the hotel request link that accepted athletes will receive. This form must be completed before 2 p.m. on 11 January 2026.

NOTE: The organization reserves the right to modify events and/or the number of participants in them and/or to cancel any of them depending on the final number of athletes entered

- * Only athletes with a National RFEA license may register for the "National Events".
- * Only athletes with a regional or national license from the FACV may register for the "P.C. FACV Regional Championship" events.
- * Only athletes with a Regional or National license by the FACV in the U18 or U20 age groups may register for the "C.V. Promotion events."
- * Registrations for the "Paralympic Relay" event will be processed directly by this entity.
- * All those events are not part of the Valencia Grand Prix, and therefore do not have access to prize money or hotel or travel subventions.

3. Registrations: Registrations for this competition will be made through the RFEA platform, strictly following the following protocol for them (no exceptions to this protocol will be accepted in the form of late registrations, changes of events or registration performances, etc.):

Registration deadline	11:00 p.m. on Sunday, January 11, 2026		
Publication of entries	2:00 p.m. on Tuesday, January 13, 2026		
Deadline for notification of withdrawals and places allocation	Until Friday, January 16, 2025 at 12:00 p.m.		
Publication of participation listings	Periodic updates will be published on the list of admitted candidates until Friday, January 16, 2025 at 5:00 p.m., at which time the final list of admitted will be published, with the series/groups/streets/order and bibs already configured for the competition.		
TIC: confirmations, changes and bibs	 The TIC will be form by a person in charge of managing results and another person in the public address system. Access to TIC will be limited to the Referee, Meeting Director and the FACV and RFEA Technical Delegate, and access to the rest of the people present in the facility is prohibited. Confirmations: Confirmation is mandatory in all races, this will be done at the competition hotel or at the entrance to the Velodrome and the cut-off time is up to 90 minutes before the start of your race. Bibs: they will be mandatory in all the tests and must be collected at the place of confirmations. 		

- **4. Protests:** An athlete, or on his behalf an accredited delegate, may make an oral complaint to the Referee. If it is rejected, it can be claimed in writing and with a deposit of € 100 to the Jury of Appeal. In the absence of this, the decision of the Referee shall be final.
- **5. Organization:** The organization may establish additional rules for the development of the competition to those contemplated in the Regulations of Competition Rules and Organization of Competitions of the official calendar for the current season.
- **6.** All athletes must go through the call room for the corresponding review of the identity of the athletes with the license or ID or passport and review of clothing, shoes, spikes, bags, bibs, etc. The deadline for presentation in the call room will be shown in the competition schedule.
- **7. Awards:** The organization establishes prize money **only for the events indicated in the table below**. No other prize money will be allocated to other events.

All athletes, national or foreign, with an RFEA national license, will be eligible for the economic prizes of the Grand Prix, in addition to foreign athletes authorized to participate in this competition by the RFEA. All prizes will have the stipulated tax deductions.














The organization reserves the right to modify or cancel the amount of the FACV prizes depending on the athletes registered in each of the events, notifying it with the final list of admitted athletes. Likewise, events may be incorporated into any of the levels of the "GP FACV".

The athletes who win each of the prizes must fill in the link they will receive by email with all the necessary information to send them the prize receipt. If they do not complete it within ten days of the Grand Prix, they will lose their right to the prize.

Athletes who do not return the signed payment document they will receive by email before 3 March 2026 will lose their right to the prize.

- 8. Gender Clause: The F.A.C.V. guarantees the effective equality of men and women as one of its basic principles of action. To this end, the generic mentions in masculine that appear in these regulations will also be understood to refer to their corresponding feminine, except in those cases in which it is specifically stated that it refers to one or the other gender.
- 9. Final Provision: Everything not provided for in these regulations will be governed by the Competition Rules and Regulations of the F.A.C.V., R.F.E.A., WA for the current season.
